

### 56K 撥號上網服務之附加條款及細則:

1. 客戶付的所有費用將不獲退還，亦不可轉讓他人。
2. 上網服務月費不包括 PNETS 附加費，此附加費將不時更改。PNETS 附加費以月結形式每分鐘計算。
3. 「香港寬頻」將不時增加及擴展撥號上網附加費，並有權就該新增加及擴展之附加服務向客戶收取額外費用。
4. 「香港寬頻」會以郵寄方式寄出月結單給予客戶，並收取每月港幣 \$ 20 (或不時訂定之金額) 的手續費 (首月免費。客戶如欲以電郵方式免費收取月結單，客戶須於「香港寬頻」網頁之服務台內登記更改。
5. 「香港寬頻」有權不時於屏幕上作任何顯示包括但不限於廣告。
6. 「香港寬頻」有權以其認為合適的方法發出各種的通知給予客戶。
7. 附送之電子郵件信箱將於申請人終止 56K 撥號上網服務時一併終止。
8. 「香港寬頻」有權以客戶的個人資料作市場推廣之用，包括但不限於郵寄宣傳單張至客戶通訊地址。客戶如不欲收取任何推廣資料，請以書面通知「香港寬頻」客戶關顧部。
9. 客戶須同時受本附加條款及細則與「香港寬頻」上網服務之一般使用條款及細則之約束。
10. 「香港寬頻」保留最終決策權停止或終止是項撥號上網全部或部份服務之權利，及/或更改一切服務條款或細則而毋須預先通知。

### Special Terms & Conditions for 56K Dialup Service:

1. All payments are non-refundable and non-transferable.
2. All Monthly Fees do not include PNETS surcharges which are subject to change from time to time. PNETS surcharge is calculated on per minute basis per month.
3. HKBN may from time to time introduce new and extension of the existing add-on services to its dial-up services, and HKBN retains all rights to charge for the use of such new or extended services.
4. HKBN will send all monthly statements to the customers by post and a handling fee of HK\$20 per month shall be charged (such amount is subject to change at the HKBN's sole discretion and the fee for the first month would be waived). If the customers would opt for receiving their monthly statements free by electronic mail, customers shall have to fill in the form online at HKBN web site.
5. HKBN shall have the right to make any display including but not limited to advertisement on the screen from time to time.
6. HKBN will send all notice to the customers in such manner as HKBN shall deem appropriate.
7. Upon termination of subscription to the Plan, all email service shall also be terminated simultaneously.
8. HKBN reserves all rights to use the Customer's personal data for marketing promotions including but not limited to sending marketing material to Customer's correspondence address. If the customers do not wish to receive any such marketing materials, please send request in writing to HKBN's Customer Engagement Department.
9. These special terms and conditions are binding on all Customers in addition to the General Terms and Conditions of HKBN Services.
10. HKBN reserves the final and sole discretion to suspend or terminate the Plan or any part thereof and make

any amendment in these special terms and conditions without prior notice.
